Data processing on the occasion of the International Day(s)

The International Day(s) comprise the following annual events organised by TU Wien:

- International Study Fair: as part of this event, TU Wien students, and possibly other interested parties, are informed about international exchange programmes and activities as well as about the corresponding grant opportunities;
- Staff Training Days: during this event, guests from TU Wien's partner universities are informed about TU Wien's best practices in the field of international cooperation and practical experiences in this field are exchanged.

As part of the event, personal data will be processed in order to organise the participation, provide promotional material and subsequently, provide information about the event. Taking photos and videos may be part of the information produced by TU Wien for the event and is specifically defined below.

Purpose of data processing

We process the personal data for the purpose of organising the International Day(s) = International Study Fair and Staff Training.

Legal basis for data processing

The legal basis for this data processing is the performance of a task carried out in the public interest in accordance with Article 6 par 1 e GDPR in conjunction with § 3 Z 11 of the Universities Act 2002.

The legal basis for producing and publishing the photos and/or videos is Article 6 par 1 (a) (Consent) GDPR.

Photos / Videos

During the event, photos and/or videos will be taken and may be published for marketing and information purposes via the TU Wien communication channels (e.g. TU Wien website, social media on which TU Wien is active, TU Wien prints).

If photos or videos are taken, the affected areas will be clearly marked, provided that this does not cause unreasonable effort, or, if applicable, the unmarked photo zones will be indicated in a suitable manner. If affected persons are in these photo areas, they consent to the taking of photos and videos.

When taking direct photos of selected guests, photographers should ask in advance whether they agree to the photo being taken or inform them of the intended photo shoot. It is not possible to obtain individual consent for room or group photos; in such cases, the reference to marked photo areas or unmarked photo zones applies.

Disclosure

The data may be disclosed to other event participants of the respective event if this is necessary for the successful realisation of the event.

The data will not be passed on to third parties.

The duration of data storage

We store the data received from you, or if applicable only a part of it, as long as it is necessary for the realisation of the International Day(s) and beyond that, as long as legal archiving periods exist or as long as legal claims can be raised against TU Wien, or as long as an authorisation has been given for this.
