



Data Protection Declaration for Lions Sponsorship

Protecting and securing data are important matters at TU Wien. Personal data is processed in strict compliance with the principles and requirements laid down in the General Data Protection Regulation of the European Union (GDPR) and the Austrian Data Protection Act. TU Wien processes only those data required for the purposes intended, and at all times endeavours to ensure the security and accuracy of the data. The protection of your personal data during the Lions Sponsorship application process is of major importance to us. In this data protection declaration, we therefore inform you which information we collect as part of your application via our applicant portal and how it is used.

Purpose of processing data:

The Lions movement, and in particular, the Lions Club Wien St. Stephan, sees the support of the general public as one of its essential duties: education, scientific studies and innovations in the area of energy and environment.

Within the scope of a closer collaboration in the area of energy and environment, the Lions Club Wien St. Stephan supports young academics and makes available a sponsorship for PhD students of the TU Wien. The support covers necessary expenses within doctoral thesis focussing on energy and environment – in particular: study trips abroad, participation at scientific congresses, scientific publications, etc.



We collect personal data directly from the participants.

Legal basis for processing data:

Data processing for participation in the prize is based on Art. 6 (1) (b) GDPR, as it is not possible to award the prize without processing the data. Photos and video recordings will only be processed with your consent within the meaning of Art. 6 (1) (a).

In the case of certain data processing operations, the fulfilment of a public task pursuant to Art. 6 Para. 1 lit e GDPR constitutes the legal basis, in this case informing the public about the fulfilment of the university's tasks pursuant to § 3 No. 11 UG.

Categories of personal data processed:

As part of the application for the Lions Sponsorship via the TU Wien online application tool, the following personal data will be collected and processed:

- name;
- address;
- date of birth;
- telephone number;
- email address;
- motivation letter
- abstract of scientific work
- university certificates
- publication list

The name of the award winner and pictures of the award ceremony will be published via the TU Wien communication channels and on the Website of the Lions Club.

Categories of recipients of personal data:

The personal data collected as part of the Lions Sponsorship will be treated confidentially and will only be disclosed within the Lions Club and the TU Wien to those who are involved in the specific selection process. Only these persons have access to the personal data.

Storage period:

We store your data until the jury meeting of the Lions Sponsorship, but no longer than one year after the award ceremony. The documents of the winners, however, will be kept permanently.

Your rights in connection with personal data:

As a person concerned by the data processing, you have the following rights towards TU Wien:

- right to information
- right to correction
- right to erasure
- right to restriction of processing
- right to data portability
- right to object

Furthermore, as a person concerned, you are also entitled to complain to the Data Protection Authority about alleged improper data processing or non-fulfilment of our obligations under GDPR.
