Legal basis for data processing:

This use of personal data is based on one of the following legal bases as applicable:

- if we need to process your personal data in order to fulfil a contract;
- in order to fulfil our legal obligations as a university institution;
- in order to perform a task in the public interest; and
- in some special and limited cases where you give your consent.

Categories of recipients of personal data:

TU Wien Pilot Factory Industry 4.0 takes the protection of your personal data very seriously. We hereby assure you that we will neither sell nor lend your data. However, in order to offer you optimum service, we may under certain circumstances be legally obliged to forward your data to certain parties. Your personal data will be forwarded to the following recipients according to statutory provisions or contractual agreements:

- public authorities that receive data due to legal requirements
- in-house offices involved in carrying out various business procedures (visitor management, event management, HR administration, bookkeeping, accounting, marketing, sales, telecommunications and IT)

Processing of voluntary information – consent:

All consents can be revoked independently of each other at any time. This revocation means that we will no longer process your data for the above-mentioned purposes from this point on and that related rights, benefits etc. can therefore no longer be claimed. Storage period:

We store your data for as long as the law requires us to do so or for as long the purpose requires; in the case of consent, until revocation.

Your rights in connection with personal data:

As a data subject, you have the following rights vis-à-vis TU Wien:

- the right to information
- the right to rectification
- the right to erasure
- the right to restriction of processing of your personal data
- the right to data portability
- the right to object
